Happy New Years to all and welcome to a new adventure.


I Hope it's not a new normal,

Our Valley started this past year the same as we ended 2020. We had the Installation of new officers, but like most other events it was by Zoom conference, Who would have thought that Zoom would have a different meaning than just going fast. We remained in a lockdown situation until the Grand Master opened the state regarding Masonry in mid-June. We slowly came back taking great precautions to keep our members safe, and things started to happen. All in all, it was a strained year, but one I can honestly say was also a very successful year for our Valley.

We had many successes. Not enormous victories, but successes just the same:

Our clinicians continued to give valuable care to our children in their speech therapy, but most was through video therapy. With parents having to be more involved, in many cases more productive therapy was the bi-product. Slowly over the last 6 months, our clinicians have started bringing some of their kids back into the building working a few



- We were able to initiate 3 new members this past Fall. And we conferred the Reunion live and in person. It was a small class, but it was still a starting point and the Reunion was tremendously successful.
- We were able to recognize another graduating senior and again awarded a \$10,000 four-year scholarship to her. We feel good that we are able to help effect lives with our Foundation dollars.
- We renewed our contract with Amazon for another year, leasing our parking lot to them for their delivery vans and employee parking. The half million dollars derived from this contract is almost 2 ¹/₂ times what we could bring in with our normal rental program in the building. And we don't need extra manpower, janitorial supplies or wear and tear on the building. We just stay out of their way and continue to collect rent checks. Our hopes are they will extend the lease for another few years. A real financial boon for our Foundation.
- Our Building Fund Campaign has come to a close. And the three-year campaign, was a huge success. We reached our initial goal, and many thanks go to all who generously contributed to this cause. The building looks fantastic; it is more efficient and will house our Valley in good stead for many years to come. Although we reached our initial goal, there are still other things we have on the drawing board,

Thirty-first Degree, Inspector Inquisitor, Part 2

In the previous article, we encountered the opening scene, where the a Knight Templar Seneschal and a Squire are contemplating and discussing drawings and hieroglyphics on the wall of a cave. The lights go down and the next scene opens.

Reception in the Hall of Justice

The candidate represents the soul of Cheres (pronounced KEY rees), an architect from the land of Chemi or Khem. In the preparation room, they remove the candidate's outer garments, including his shoes and socks, and cover him in a loose fitting white cotton sheet, with a cord around this waist. They place a skullcap over his head, covering his hair and ears. There is no blindfold, the candidate enters the Hall of Justice with eyes open.

The Hall is dimly lit. There is a large balance-beam scale, representing the scales of Maat, an altar with a closed Book of Constitutions on top. Nearby is a life-size representation of a mummy, which represents the dead and embalmed body of Cheres. In each corner of the Hall is a small altar with a censer for burning incense.

As the candidate enters the Hall of Justice, Horus, the falconheaded god, greets him: "O soul of Cheres, you have come to the Court of the Dead, where you body lies before the judges, waiting to have your interment granted or denied. You shall be judged according to the deeds performed while you were yet in the flesh, rendered according to the will of the gods of Egypt."

Isis, queen of the afterlife appears, holding her scepter and an ankh (see the discussion of the ankh at the end of this article). She asks "What soul is this, O Horus whom you bring into the Court of the Dead?" Horus answers that the soul belongs to Cheres, an Egyptian, who recently died.

Suddenly there is a flash of brilliant light, after which the Hall seems almost completely dark. Then Duamutef, the jackal-headed son of Horus, states for the record, "To those who receive favorable judgement here, the great god speaks, and they speak to him. He refers to the supreme deity, Amun-Ra.

Kebehsenuef, the falcon-headed son of Horus, states the alternative," To those who receive unfavorable judgement here, they do not behold the great Amun-Ra. Their eyes shall not receive the rays that flow from his being nor shall they hear his voice. Their souls shall not be manifested or made illustrious in the world.

Isis commands, "Let him approach the scales and remain near the body (Cheres's mummified corpse). Horus conducts the candidate near the mummy. There is another flash of dazzling light.

Atum, the creator god and solar deity, asks, "Who is this soul that stands by his body, to be tried by the Court of the Dead?" Horus responds, "O Atum! This is the soul of Cheres, an Egyptian, a builder of the city of Memphis, who recently died there. Atum asks, "What does he answer for himself?"

Horus, speaking for the soul of Cheres, says, "I have obeyed the laws of the land of Egypt... I have not neglected the worship of the

gods... The contracts that the law requires me to keep, I have kept... I have restored whatever was entrusted to my keeping..."

Atum asks, "Who can vouch for Cheres's word or does anyone accuse him of lying?" Imsety, the human-headed son of Horus, responds that Cheres told the truth and there are no grounds to condemn him for any offense. Atum asks whether the strict rule of law was Cheres's only motivation. Imsety says it might be true, and if so, it reflects less merit in Cheres's life.

Hapy, the hippo-headed son of Horus, describes Cheres's life of zealous religious observance and his sober and virtuous life. Maat, the goddess of truth, asks whether Cheres's observance happened only when it was convenient for him or was he regular and consistent. Hapy does not know but if his observance was irregular, Cheres's soul is in great danger.

Duamutef testifies of Cheres fulfilled his contracts, paid his taxes on time, and did not overcharged his customers. Atum asks whether Cheres was just following the letter of the law. Duamutef does not know, but he says the balance (referring to the scales of Maat) will tell.

Kebehsenuef testifies answered truly and had the character of an orderly, honest, and reputable citizen. Maat asks whether Cheres was just doing his civic duty without being merciful and generous, and did he seek the praise of men rather than care for the widows and fatherless children.

Kebehsenuef replies that such is often the case with men.

Atum calls out to Thoth, the ibis-headed recorder of the gods, "O Thoth, have you the account of the deeds of his life which will truly answer the questions about Cheres?" Thoth replies, "O Atum! It is written." So Atum commands, "Then weigh in the scales of truth (the scales of Maat) all the goodness of his soul."

The First Verdict

At this point, Anubis, the jackal-headed god in charge of the dead, places a few small weights onto one side the scale, causing the other side to rise. Then he reports, "O Atum and Maat, the goodness of his soul does not suffice for the demands of the justice of the gods." Needless to say, this is bad news for Cheres.

Atum comments that the justice of the gods is not fallible and imperfect like human justice. Obeying the law and the king, refraining from crime and fraud, complying with outward religious observance, and living properly and soberly are all good things, but they are not enough to earn the favor of the gods.

Maat adds, "And one may so live his whole life and yet be unfit to have lived at all. There are foul deeds that no human laws punish and good deeds that no human law requires or rewards. Strict outward religious observance duty may be just a mask. An outwardly pious life may be coupled with selfishness and heartless indifference to the welfare of others. A spotless reputation may cover up an uncharitable heart, hated, malice, and envy."

Cheres Appeals to Amun-Ra

Horus asks, "O King Osiris, the soul of Cheres desires to be questioned further, and to abide the judgement that shall be given." This proposal is like appealing to a higher court. At this juncture, the gods and goddess assume different positions around the Hall, and Horus conducts the candidate to the altar in the northeast corner.

Isis directs the soul of Cheres swear to the great god Amun-Ra to answer truthfully. Atum notes that the gods will know. Maat expands on it, saying that the gods have known all that he (Cheres) has done, said, and thought throughout his life.

Kebehsenuef lights the fire in the censer near him and says, "This human soul (referring to Cheres), naked before the just gods, invokes the great god Amun-Ra to hear, and unto him does sacrifice and swear that he will answer truthfully." Prompted by Horus, the candidate says, "King Amun, hear me! I will answer truly, so help me all the gods!"

There is a sudden blast of light. Then Kebehsenuef throws incense onto the fire. Isis states, "Amun is light. He hears, O soul of Cheres! Speak the truth and if there are reasons why the wrong or error should be overlooked or deemed atoned for, make them known. This is no idle examination. You are required to make a clear and honest reply to each question."

1. In your life, have you ever tempted anyone to do something wrong or dishonest? 2. Have you ever bought judgment or favor with money, or perverted it by influence or deceit? 3. Have you ever sold or abused your talent to help the wrong to succeed against the right? 4. Have you sold and unsound or inferior thing by falsely representing its quality? 5. Have you said unkind words of any, to whom you have made vows of brotherhood?

Isis adds, "No man is always free from sin and error, performs every duty, keeps ever promise, and fulfills every vow. The gods know how weak and prone to error men are. If you wish to change or add to any answer you have made, to extenuate any ill act done, or to show that you have repented of, atoned and made amends for any wrong that you have done, the gods will hear you patiently." At this point, the candidate is free to answer or remain silent.

Isis checks with Thoth, the ibis-headed god and recorder of the court, to verify he has written all of Cheres's answers. Thoth responds that he has. Then Isis says, "Let the soul of Cheres answer at the altar of the great god Kneph, the spirit of the universe." Horus conducts the candidate to the altar in the northwest corner.

Cheres Appeals to Kneph

Nephthys, the savior sister goddess, directs the soul of Cheres swear to the great god Kneph to answer truthfully. Duamutef lights the fire in the censer near him and says, "This human soul (refering to Cheres), naked before the just gods, invokes the great god Kneph to hear, and unto him does sacrifice and swear that he will answer truly." Prompted by Horus, the candidate says, "O Kneph, hear me! I will answer truly."

Suddenly a gong sounds followed by a vivid blaze of light. Duamutef throws incense onto the fire. Nephthys states, "Kneph is the spirit of the universe, the intellect that becomes the word. You cannot deceive him, O Cheres!"

I. Have your preaching and your practice every been contrary to each other? 2. Have you made the law the measure of your morality, and thought that if an act was exempt from punishment, it was justifiable? 3. Have you had your religion for the temples and for public display, and laid it aside in your dealings with men, in your disputes, and your pursuit of pleasures? 4. Have you thought it sufficient to believe devoutly whatsoever is said in the holy writings and by the priests, and that faith alone would atone for failure to live well, as the holy religion requires? 5. Have you prayed to the gods for forgiveness, while yourself being unforgiving or ungrateful?

Nephthys checks with Thoth to verify he has written all of Cheres's answers. Thoth responds that he has. Then Nephthys says, "Let the soul of Cheres answer at the altar of the great god Khem, the procreator." Horus conducts the candidate to the altar in the southeast corner.

Cheres Appeals to Khem

Isis directs the soul of Cheres swear to the great god Khem, the renewer of life, to answer truthfully. Insety lights the fire in the censer near him and says, "O Amun Khem, the victorious, this human soul, naked before the just gods, invokes you to hear, and sacrificing to you swears he will answer truthfully." Prompted by Horus, the candidate says, "O

Amun Khem, hear me! I will answer truly!"

There is a sudden burst of light . Then Imsety throws incense onto the fire. Isis states, "You have your life from Khem, O son of Suphis (referring to Cheres)! If you lie to him or equivocate, He will put that life out."

1. Have you failed to keep promises in the spirit, while keeping them in the letter? 2. Have you been a false friend or treacherous enemy to anyone? 3. Have you taken advantage of a fraud or mistake that was unknown to another, and made gain thereby? 4. Have you kept from anyone that which you could keep by law, but which in equity or good conscience was not rightfully yours? 5. Have you, in the interest of respectability, been relentless in condemning and swift to punish those who have erred and gone astray?

Isis adds, "If you wish to explain any answer that you have made, or to extenuate, or to show that you have repented of, atoned for, what you cannot deny having done, the judges of the Court of the Dead will hear you patiently." At this point, the candidate is free to answer or remain silent.

Isis checks with Thoth to verify he has written all of Cheres's answers. Thoth responds that he has. Then Isis says, "Let the soul of Cheres answer at the altar of the great god Ptah, the artificer of the world." Horus conducts the candidate to the altar in the southwest corner.

Cheres Appeals to Ptah

Nephthys warns the candidate, "Ptah is the lord of truth and he punishes falshood. So weigh well what you shall reply!"

Imsety lights the fire in the censer near him and says, " O Ptah, artificer of the world and lord of truth, this human soul (referring to Cheres), naked before the just gods, invokes you to hear, and sacrificing does and swear that he will answer truthfully." Prompted by Horus, the candidate says, "O Ptah, hear me! I will answer truly!"

1. Have you contributed to showy charities, the you might be named in the market places and the temples, while sending from your door the hungry and destitute whom the gods sent do test you? 2. Have you pretended to be devout, while being the slave in secret of some vice or sin? 3. Have you endeavored to raise the fallen, and been merciful and lenient to the erring? 4. Have you foregone revenge when you could have had it, and spared those you could have humbled, even when they had done you wrong? 5. Have you ever, in any considerable thing, preferred another's interest and profit to your own, or sacrificed your chances for preferment and honors within your reach, to serve and further a friend?

Nephthys gives the candidate the opportunity to explain any answer he has given, or to lessen, excuse, or extenuate any wrong he cannot deny having done. The judges of the Court of the Dead will hear him patiently. After a few moments, a gong sounds.

Nephthys checks with Thoth to verify he has written all of Cheres's answers. Thoth responds that he has. Then Atum says, "Then place in the scales what of good the soul of Cheres should have honor for, and what in justice and truth should weigh against it."

At this point, Anubis, places a few small weights onto the other side the scale, causing it to balance in the center. Then he reports, "O Atum, the good and bad are so nearly balanced that a little weight in either side of the scale will weigh it down." Atum reports the findings to King Osiris.

King Osiris replies, "Let the soul of Cheres (referring to the candidate) sit near his body alone. Return my sisters (Isis and Nephthys) to your thrones. Thoth and Anubis will now collect the opinions of the assessors (Egyptian gods watching from the sidelines)".

Horus conducts the candidate to a seat by the mummy. Meanwhile, Thoth and Anubis go around collecting opinions from each of the assessors. After they are done, Thoth reports to Osiris that a majority of the assessors think that the soul of Cheres should be judged to deserve the favor of the gods. Some of the assessors think he should be condemned and made to atone, until he is purged of his imperfections. None of the assessors think he should be condemned to eternal banishment.

King Osiris orders the sons of Horus (Duamutef, Kebehsenuef, Imsety, and Hapy) to consider the opinions of the assessors and give their conclusions to Atum and Maat. Thoth takes a scroll listing the opinions of the assessors to each of the four sons. Then each son approaches Atum and Maat, seated on their thrones, and gives his opinion. Finally Atum arises and informs Osiris that three of the sons agree with the majority of the assessors, that the soul of Cheres deserves the favor of the gods.

However one of the sons agrees with the minority of assessors that Cheres was too lenient with himself, causing him to deny his unworthy motives and illegal actions during his mortal life. Thus, the soul of Cheres does NOT deserve admission to the realm of light. And Atum agrees with the dessenting son.

The Maat stands and expresses her agreement with the three sons and the majority of the assessors, adding that good men sometimes do bad things while bad men sometimes do good things. She finds that the soul of Cheres is neither bad nor base.

The Final Verdict

Now the final decision is in the hands of King Osiris, who comments, "The strong who easily resist temptation are less deserving than the weak who struggle to overcome. To fall and rise again is more heroic than avoiding failure. To do wrong and then make amends, to sin and then repent, belong to a noble nature. The gods love mortals all the more because they are imperfect, even as parents love their children, despite their weaknesses and faults." Osiris raps his gavel three times. "My judgment upon the life and soul of Cheres is that he is worthy. Let his soul enter into the realm of everlasting light, rest, and peace. This trial has ended."

The lights go down and the final scene opens. We are back in the cave with the Senechal and Squire. The Senechal recounts the lesson of the court and gives the Squire a small statue he found to help him remember. The two leave the cave and return to their camp, and the degree is closed.
